Please see attached correspondence from Harold Garverick. He is requesting the return of \$10,890 that he donated to the District in 1994. See the attached excerpt from Board of Education Minutes dated April 14, 1994.

Annual scholarships of \$250 have been awarded to Galion students from this fund for almost 20 years from the accumulated interest earned on this donation.

As of February 27, 2015 the Garverick Scholarship Fund had a balance of \$10,890 in principal and \$44.72 in interest. Based upon the current interest rates earned on funds deposited with the District it will be several years until a \$250 scholarship can be awarded from this scholarship fund.

I recommend the return of principal and interest, \$10,890.00 and \$44.72 respectively, to Mr. Harold Garverick.


Dear Donors,

# *Marjorie Garverick Leyden Scholarship*

## BY-LAWS OF THE MARJORIE GARVERICK LEYDEN SCHOLARSHIP FUND

The family of Marjorie Garverick Leyden has donated funds to Galion City Schools for the purpose of establishing a fund to be known as the Marjorie Garverick Leyden scholarship fund.

This fund is to be maintained and the funds therein invested by the Treasurer of Galion City Schools. Marjorie's family has further indicated they may, from time to time, make additional deposits to the fund in order to increase the amount of the scholarship awarded each year.

The amount of the scholarship awarded each year is not to exceed the interest earned on the principle in the proceeding year. The principle is not to be expended.

The selection committee for this scholarship is to consist of the following Galion High School Staff Members:

1. Athletic Director
2. Head Guidance Counselor
3. Principal

It is the wishes of the family of Marjorie Garverick Leyden that the following criteria be used to select the Marjorie Garverick Leyden scholarship recipient each year:

1. Must be female.
2. Must be a member of the graduating class of Galion High School.
3. Must plan to attend an accredited post secondary school.
4. Must be from a family of modest income.

NOTE: The recipient does not have to be selected based on academic achievements. The family desires an "overachiever" type person with modest income be selected for this scholarship.
