This agreement entered into this _____ day of _____, 2016 by and between Galion City School and RC Therapy Services, Inc. herein referred to Galion City Schools and RC Inc. for the 2016-17 school year.

For mutual consideration, the parties hereby agree as follows:

ARTICLE ONE: General Duties of RC Inc.

1. Services: RC Inc. will:

- a. Conduct initial screenings and/or evaluations to identify school students needing physical therapy services as referred by professional staff of Galion City Schools.
 - b. Develop individual treatment or program plans with goals and/or objectives based on the evaluation.
 - c. Conduct direct and/or indirect physical therapy services.
 - d. Coordinate with staff, parents, and other family members regarding procedures to complement/facilitate the therapy program.
 - e. Consult with program staff on activities, positions, procedures etc. to maximize the student's potential and to enhance the educational process.
 - f. Keep updated student records, including individual program plans and reports of student's progress.
 - g. Participate in interdisciplinary team meetings as requested.
 - h. Conduct inservice training for staff and/or family members as requested.
2. Insurance: RC Inc. shall maintain comprehensive liability/malpractice insurance for physical therapy services provided.

ARTICLE TWO: General Duties of Galion City Schools

1. Will advise RC Inc. promptly of any physician orders, requests, or services related to the student's treatment.

2. Agrees to provide rent free, such space as is reasonably required to enable RC Inc. to perform duties and services.
3. Agrees to provide adequate secretarial services to type documentation which is required by Galion City Schools and which is related to said therapy services.
4. Inform and include RC Inc. in IEP meetings regarding students receiving therapy services.

ARTICLE THREE: Frequency of Services and Fee Schedule

RC Inc. will provide on premises physical therapy services and school/home programs as needed. Said services shall coincide with the school calendar of Galion City School. Galion City School agrees to compensate RC Inc. at a rate of \$63.00 per hour for services provided.

This will be achieved through standard billing procedures of RC Inc. and will be payable within 30 days of billing.

ARTICLE FOUR: Additional Contracts

It is expressly understood by and between the parties hereto that RC Inc. does have and may continue to have contracts with other facilities, in addition to the services to be rendered by virtue of this agreement.

ARTICLE FIVE: Best Efforts of Employee

The service provider agrees that she will at all times perform all of the duties here under, to the best of his/her ability.

ARTICLE SIX: Agreements Outside of Contract

This contract contains the complete agreement between the parties and shall, as of the effective date hereof, supersede all other agreements between parties. The parties stipulate that neither of them has made any representation with respect to the subject matter of the Agreement or any other representations including the execution and delivery hereof, except such representations as are specifically set forth herein, and each judgment in entering into this Agreement.

ARTICLE SEVEN: Modification of Contract

No waiver or modification of this Agreement or of any covenant, condition, or limitation therein contained shall be valid unless in writing and duly executed by the party to be charged therewith.

ARTICLE EIGHT: Choice of Law

This Agreement shall remain in full force and effect for a period of one school calendar year. Either party hereto may terminate this contract in thirty (30) days, by giving the other party hereto written notice by certified mail.

The parties hereto agree to review the provisions of this Agreement prior to the termination of the Agreement with the view of ascertaining whether this Agreement, or a revision thereof, is necessary or advisable to provide adequate therapy services.

ARTICLE NINE: Paperwork/Documentation

The facility agrees to allow the service provider to use her routine documentation system, provided that paperwork meets all standards and requirements of mandatory certifying agencies and reimbursement systems.


RC Inc. agrees to comply with the requirements of 45 CFR 164.504(e)(1) for safeguarding and limiting access to information concerning students/beneficiaries.

RC Inc, will allow the representatives of the US Department of Human Services, ODJFS, ODE, or their respective designee, access to the provider's books, documents, and records related to provision of said services for Galion City Schools.


RC Inc acknowledges that all service providers hold current and valid licenses required for provision of said services and service providers are not suspended or disbarred.
