This Purchase Order, together with the Natural Gas Agreement between Seller and Buyer, dated May 23, 2016, constitutes a Contract between:

Price Calculation: Buyer agrees to pay Seller for all volumes of natural gas consumed within the Contract Volume +/- 0% in a given contract month at the price specified below in section 4 below. Buyer may convert up to 100% of the Contract Volume to a Fixed Price in the manner described in the Natural Gas Agreement. If Buyer has converted some or all of the Contract Volume to a Fixed Price in a given month, the price for all gas consumed in that month within the Contract Volume +/- 0% shall be calculated by taking a weighted average price for all Fixed Price conversions and any remaining Contract Volume at the price specified in section 4 below.
