

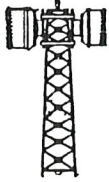
I apologize for the delay, however, this is a complex situation which needs attention. I will get back to you as soon as I have an answer.

On April 16, 1996 Rinehart Tower Service, Inc. inspected the football field towers. Our standard tower inspection and maintenance report was completed. We recommend the following to be done on each tower.

- (1) Install Safety Climbing Device to meet OSHA standards.
- (2) Install 6 ft. High Fence around tower for security.
- (3) Install new Lighting System to reduce wind loading.
- (4) Reduce height of tower or replace damaged tower legs.
- (5) Install Tower Grounding to protect tower lighting system.
- (6) Annual Inspection & Written Inspection Report to assure that everything is in good condition and working properly.

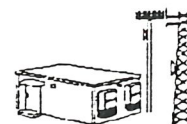
