NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE GALION CITY SCHOOL DISTRICT:

THAT this Board hereby determines that it is necessary to levy an additional tax outside of the ten-mill limitation for a period of five (5) years as follows: \_\_\_\_\_ (\_\_\_\_\_) mills for the purpose of current expenses and \_\_\_\_\_ (\_\_\_\_\_) mills for the purpose of ongoing permanent improvements as authorized by R.C. 5705.217, for a total tax levy of \_\_\_\_\_ (\_\_\_\_\_) mills.

THAT this Board hereby requests that the Auditor of Crawford County, Ohio, certify to this Board:

1. The total current tax valuation of this school district;
2. The dollar amount of revenue which will be generated per year by the levy of an additional tax of \_\_\_\_\_ (\_\_\_\_\_) mills for the purpose of current expenses and \_\_\_\_\_ (\_\_\_\_\_) mills for the purpose of ongoing permanent improvements, for a total tax levy of \_\_\_\_\_ (\_\_\_\_\_) mills, to be submitted to the electors at a special election to be held on May 7, 2013, being the same day as the primary election.
