



Last Will and Testament

OF

DARLENE V. SMITH

I, **DARLENE V. SMITH**, of the City of Galion, County of Crawford and State of Ohio, being of legal age, sound mind and memory, and under no restraint, do publish this, my last Will and Testament, revoking all others heretofore made by me.

ITEM I

I declare that I am a widow and have no children.

ITEM II

I hereby direct that all of my just debts, my funeral expenses (including the cost of a suitable monument at my grave) and the cost of administration of my estate, be paid from my estate.

ITEM III

I give, devise and bequeath my estate as follows:

1. To David Pirnstill, 412 Rensselaer E., Bucyrus, Ohio 44820, my residence, and all of the household furnishings located therein, as well as lawn equipment and my 1991 Ford truck.
2. To the Crawford County Humane Society, the sum of One Thousand Dollars (\$1,000.00) given in the name of Richard & Darlene Smith.
3. To Shirley Munderloh, of Savannah, Georgia, all funds in my savings accounts at Galion Building & Loan Bank of Galion, Ohio, United Bank, Galion, Ohio and First Federal Bank

of Ohio, Galion, Ohio. I do not leave, however, my Certificates of Deposit and my Edward Jones accounts to Shirley Munderloh.

4. All the rest, residue and remainder of my entire estate, both real and personal or mixed, of every kind, nature and description whatsoever, and wheresoever situated, which I may own or have the right to dispose of at the time of my decease, including all property which I may acquire or become entitled to after the execution of this Will, including all lapsed legacies and devises, to the Galion City School District, IN TRUST, absolutely and in fee simple, for the specific purpose of establishing annual scholarships for members of the student body. This scholarship fund shall be in the name of "The Richard S. Smith and Darlene V. Smith Foundation". The superintendent of the Galion City School District, the president of the Galion City School District Board of Education and a member or a successor of the Wagner Law Firm, P.L.L., Galion, Ohio, shall be designated Trustees. Only the net income from this bequest shall be used for scholarship purposes. The availability of the Foundation's Scholarship funds shall be made to all students in the senior class of the Galion High School. All recipients shall be known as "Richard S. Smith and Darlene V. Smith Scholars". The Trustees shall meet annually to determine the amounts of scholarship monies to be awarded and the recipients of same. Scholarships may be given not only to attend college, but also to attend trade school, nursing school, etc. Payments to post-high school education institutions shall be made directly to the institution and will be limited to tuition. Scholarships shall not be awarded for room, board, transportation or entertainment.


ITEM IV

I hereby grant my executors full power and authority to sell and convey all or any part of my estate, real, personal or mixed, upon such terms and at such prices as they may deem proper, and without any Order of Court therefore. I also grant my Executors full power in the settlement of my estate, for such sums and upon such terms and conditions and in such manner as he shall deem best.


I direct that no bond be required of any Executor named herein.
